

TERRITORY GENERATION - BULLETIN 6/2015

VOTE on new 2015-2018 Territory Generation Enterprise Agreement

As previously reported in [Bulletin 5/2015](#) the unions have provided in-principle agreement to my [improved offer](#) for a new enterprise agreement, which included salary increases of 3% per annum over a three year agreement.

Delegates from my Office, Territory Generation and the unions have finalised drafting of the new 2015-2018 Territory Generation Enterprise Agreement (the proposed Agreement), which can now be put to a formal ballot.

Ballot Process

On Monday 20 July 2015 you will be sent a link to the proposed Agreement and an explanatory document highlighting the changes compared to your current agreement. Hard copies of these documents will also be available throughout your workplace.

The ballot process will be conducted by the Northern Territory Electoral Commission (NTEC), which will involve a mail-out to your address nominated in the NTPS myHR system. The ballot material will include a ballot paper, ballot envelope and return post-paid envelope.

Ballots will be posted to your address details contained in myHR as at 10 July 2015. If your details have changed since this date, or you would like the ballot posted to an alternative address, you should contact Sue Whyte at NTEC on 08 8999 7643 or susan.whyte@nt.gov.au as soon as possible.

The timetable for the ballot is:

20 July 2015 (Monday)	Distribution of Agreement and Explanatory Notes
23 July 2015 (Thursday)	Mail-out of ballot forms
28 July 2015 (Tuesday)	Ballot OPENS
11 August 2015 (Tuesday)	Ballot CLOSES 10 am

Ballot counts will be conducted simultaneously at NTEC Offices in Darwin, Level 3 TCG Centre 80 Mitchell Street Darwin, and Alice Springs, MyVote Central, Yeperenye Centre Hartley St Alice Springs. The Commissioner will advise employees of the ballot result via a bulletin and a notice on the enterprise bargaining website listed above.

Ballot Outcome

If the majority of you who vote in the ballot are in favour of the proposed agreement (a 'yes' vote), and the Fair Work Commission approves the agreement, the initial 3 per cent salary increase will be payable from 16 July 2015.

If the ballot does not result in a 'yes' vote then I will need to consider available options, and in accordance with the NTPS Wages Policy 2013-2016, the effective date of any salary increase will be delayed.
